In addition, the underpad has sealed edges for optimum leak protection, and the surface is covered with a soft non-woven material for enhanced user comfort. The use of disposable underpads reduces the risk of contamination. Abri-Soft Basic offers light to moderate absorbency and is available in different sizes. It is also available in a versions with flaps and a version with tape, which are useful for active or restless users, as the underpad is fixed on the sheet
